



Privacy Statement

We understand that you may not want to share your personal data with everybody. That is why we are careful with the information you share with us. We adhere to the General Data Protection Regulation (GDPR). To fulfil our mission as a coach, we do need some personal data to be able to help you effectively. In this statement, we explain which data we need from you, what we use it for and how we protect it.

Yann Ghisalberti is your coach at Coach4ADHD. Our practice is located at Voorplecht 13, 1186 WP in Amstelveen, Netherlands. Purpose to collect personal data

We process personal data to be able to provide our coaching services.

As a registered ZZP'er (Zelfstandige Zonder Personeel) in the Netherlands, we must also comply with legal obligations regarding the collection and processing of your personal data.

We do not trade personal data.

Which Personal Data Do We Collect?

We may collect the following personal data from you:

- Contact Information: Name, email address, phone number, and any other information you provide when contacting us through our website <https://coach4adhd.nl/>.
- Website Usage Data: Information about your activity on our website <https://coach4adhd.nl/>, such as pages visited, time spent on the website, and browser information. This data may be collected through cookies and similar tracking technologies.
- Personal Data relevant in the process of the coaching (such as feelings, background, life events etc.). Some of these Data are considered as Special and Sensitive Data according to the GDPR (such as Data concerning health, medicine, sexual orientation) and are processed and protected as such by Yann Ghisalberti from Coach4ADHD.

How Do We Use Your Personal Data?

We use your personal data for the following purposes:

- To provide and improve our services: This includes responding to your inquiries, providing information about our coaching services, and processing your requests.
- To personalize your experience: We may use website usage data to personalize your experience on our website <https://coach4adhd.nl/> by tailoring content to your interests.
- To send you marketing communications: We may use your contact information to send you marketing communications, such as newsletters and promotional offers, but only with your consent. You can opt-out of receiving marketing communications at any time.
- To comply with legal obligations: We may use your personal data to comply with legal obligations, such as responding to court orders or subpoenas.



Legal grounds

The processing of your personal data must be done in accordance with one of the legal grounds of the GDPR. In our case, the following legal grounds apply: a legal obligation, a contract, a legitimate interest and your permission.

- Legal obligation: we must process (store or provide) certain personal data in the context to comply with the law (such as the fiscal law).
- Performance of a Contract: to be able to execute our obligations under the coaching contract, we need to process personal data.
- Legitimate interest: We process website usage data for our legitimate interests in improving our website <https://coach4adhd.nl/> and providing you with a better user experience.
- Consent: for all other information, that is, if the processing of personal data is not covered by one of these legal grounds, we will request your consent to process certain personal data. It will be the case for example for marketing purposes. You can always revoke this consent by sending an email to yann@ghisalberti.nl.

How Do We Share Your Personal Data?

We may share your personal data with third-party service providers who help us operate our website, the payment system and provide our services. These third-party service providers are contractually obligated to protect your personal data and to comply with the GDPR. We will not share your personal data with any other third party without your consent, except as required by law. We will not trade your personal data.

Data Retention

We will retain your personal data for as long as necessary to fulfil the purposes for which it was collected, unless a longer retention period is required or permitted by law.

Your Rights Under the GDPR

You have several rights under the GDPR, including the right to:

- Access your personal data: You have the right to request a copy of the personal data we hold about you.
- Rectify your personal data: You have the right to request that we rectify any inaccurate or incomplete personal data we hold about you.
- Erase your personal data: You have the right to request that we erase your personal data in certain circumstances.
- Restrict the processing of your personal data: You have the right to request that we restrict the processing of your personal data in certain circumstances.
- Object to the processing of your personal data: You have the right to object to the processing of your personal data in certain circumstances.

If you wish to exercise any of these rights, please contact us using the contact information provided below.

Security

We take reasonable steps to protect your personal data from unauthorized access, disclosure, alteration, or destruction. However, no storage, no website or internet transmission is completely safe secure.



Complaints

If you believe that we are processing your personal data in violation of the GDPR, you can submit a complaint at yann@ghisalberti.nl. We will handle your complaint with diligence and, if necessary, seek advice from the Dutch Data Protection Authority (AP). If you do not agree with how we handle your complaint, you can file a complaint directly with the AP. They will handle your complaint or request and take a decision.
